NOT GUILTY PLEA OR GUILTY PLEA and CONSENT TO JUDGMENT

I wish to enter a plea of **GUILTY** and as the undersigned defendant, I hereby state the following:

Initial I understand that I have been charged with § _____, Arizona Revised Statutes, a petty offense with a possible sentence of a maximum fine of \$500.00, including surcharges for each charge.

Initial I understand that I have the right to a trial, the right to be represented by an attorney, the right to confront and cross examine witnesses, the right to compel witnesses to testify on my behalf, the right to remain silent and be presumed innocent until proven guilty beyond a reasonable doubt, and the right to a direct appeal.

Initial I understand that should I be charged with section A.R.S. § 13-3904 for a VIOLATION OF A PROMISE TO APPEAR on my court date, that this is a class 2 misdemeanor with a possible penalty of 4 months in jail, a maximum fine of \$1,431.40 and two years probation.

Waiving my Constitutional Rights, I hereby enter a plea of **GUILTY** to the above captioned petty offense(s), and **CONSENT TO JUDGMENT** imposing the prescribed fine for that offense on the enclosed bond schedule. I understand that this plea shall be deemed accepted, and the judgment and sentence imposing the prescribed fine shall be deemed pronounced on the plea, **when the fine is paid and this form is received.**

Initial I wish to enter a plea of **NOT GUILTY** and agree to appear on the date and at the time as ordered by the Court.
