**If you have been cited for ARS 28-645A3A (RED LIGHT VIOLATION), or ARS 28-647 (DISOBEY FLASHING SIGNAL), or are under the age of 18 (FIRST OFFENSE) and are found responsible for a moving violation, the Arizona Motor Vehicle Department will require you to attend a Traffic Survival School pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving School and complete a class at least 7 days prior to your court date, the violation will be dismissed, and you will not be required to attend Traffic Survival School by the Motor Vehicle Division.**

Bullhead City Municipal Court is open from 8:00 am until 12:00 pm and from 1:00 pm to 5:00 pm Monday through Friday.

If you are under 18 years of age, a parent/guardian must accompany you to Court.

If the charge filed against you is a CRIMINAL TRAFFIC or a MISDEMEANOR, you must appear in court on the date and time specified on the traffic citation.

CIVIL TRAFFIC cases can be resolved prior to the appearance date on your citation by one of the three following options:

Option 1)

- Plea Responsible and pay the fine. A court appearance is not required. Payment can be made as follows:
  - By mail with a cashier's check or money order payable to Bullhead City Municipal Court.
  - Online @ [bullheadcity.com/municipalcourt](http://bullheadcity.com/municipalcourt)
  - By phone @ 855-814-0104

Option 2)

- Plea Not Responsible and request a Civil Traffic Hearing. A court date will be set for you to appear before the Judge. Your court date will be sent to you by mail or email. Civil Traffic Hearings can be requested as follows:
  - By completing the hearing request on this form
  - By e-mailing the court
  - Submitting your request thru the city website, [bullheadcity.com/municipalcourt](http://bullheadcity.com/municipalcourt)

Option 3)

- Complete a defensive driving class at least 7 days prior to the appearance date on your citation. You may complete defensive driving for dismissal of one moving violation every 12 months. Commercial Driver License (CDL) holders are not eligible for defensive driving. The court will only accept classes which are certified by the Arizona Supreme Court. To find an approved class, call 1-888-334-5565 or visit the website [www.azdrive.com](http://www.azdrive.com)

If you complete defensive driving:

- You will not pay the fine to the court
- You will not have to go to court for that violation
- The violation will be dismissed, there will be no points

**PLEA RESPONSIBLE AND PAY YOUR FINE BY MAIL**

You are admitting Responsibility for the violation(s). The court will enter a Plea of Responsible and report the finding to the Arizona Department of Transportation Motor Vehicle Division. Points will be assessed to your record for any moving violations. By entering a plea of Responsible, you are no longer eligible for defensive driving.

1. Find your violation code(s) on the fine schedule. If the violation does not appear on the schedule, contact the court by phone or e-mail for more information.
2. Fines can be paid with a cashier's check or money order payable to Bullhead City Municipal Court. Debit/Credit card payments can be submitted by completing the bottom portion of this section.
3. Fill in all payment information below.
4. Return this completed section, along with payment and a copy of the citation, in the envelope provided. Place correct postage on the envelope.
